QUALIFICATIONS:

MINIMUM QUALIFICATIONS:

Possession of a current Louisiana license to practice professional engineering plus seven years of professional engineering experience.

SUBSTITUTIONS:

A master's degree in engineering will substitute for one year of the required experience.

A Ph.D. in engineering will substitute for two years of the required experience.

Advanced degrees will substitute for a maximum of two years of required experience.

NOTE:

Applications will be accepted from persons licensed to practice professional engineering in states other than Louisiana. If one of those applicants is selected for the position, he/she will be required to obtain a Louisiana license prior to appointment. The hiring agency will verify that all licensing requirements are met.

NOTE:

Engineering experience gained prior to earning a professional engineer's license (e.g., as an engineer intern applicant, engineer intern, or equivalent) will be accepted as professional level engineering experience.

NOTE:

Any college hours or degree must be from a school accredited by one of the following regional accrediting bodies: the Middle States Commission on Higher Education; the New England Association of Schools and Colleges; the Higher Learning Commission; the Northwest Commission on Colleges and Universities; the Southern Association of Colleges and Schools; and the Western Association of Schools and Colleges.

Analyzes and assigns priorities to needs; makes program and budget recommendations to the department director.

Monitors contract construction and maintenance projects in a port district; monitors project progress; reviews plan changes; performs periodic and final inspections; recommends final acceptance of completed projects to the Port Authority.

Review the purchase of equipment and materials.

Confer with other public agencies concerning district activities, projects, and work force.

Investigates and responds to complaints by public officials and the general public.

Supervise the planning and port development staff.
